Scope of Work

The Global Payroll Provider should possess the following:

- Proven experience in providing global payroll services in a variety of locations.
- A software system which complies with relevant local and international payroll regulations, specifically in relation to pay as you earn (PAYE) or similar tax calculations and any other compulsory legislated tax deductions.
- Ability to provide software to handle payroll processes in multiple currencies across multiple jurisdictions (including non-state jurisdictions).
- Strong data security and privacy protocols.
- Excellent client references and track record of successful project delivery.

Deliverables

The Global Payroll Provider software system is expected to deliver the following:

- Access to International IDEA staff to input staff payroll data from multiple locations
- Monthly payroll reports for all employees, including gross and net salaries, deductions, and taxes.
- Annual tax statements for employees as required by local laws.

• A dedicated support channel for employee queries and issue resolution.

Qualifications and Experience

The ideal Global Payroll Provider should possess the following qualifications and experience:

- Proven track record in managing global payroll services.
- Comprehensive knowledge of international payroll laws and regulations.
- Capability to handle payroll for employees in multiple countries with varying legal requirements.

- References: Contact information for at least three client references (non-profit International Organisations) who can attest to the firm's capabilities and performance.
- Data Security Plan: Description of measures in place to protect employee payroll data.
